Full Summer Session (12W) – May 13 to August 12

May 13	Summer (12W) classes begin.
May 13-19	Late registration/schedule adjustment period for Summer (12W) Session. Late registration fee in effect.
May 19	Last day to register, add courses, or change sections for Summer (12W) Session. Final date to drop courses or totally withdraw with no grade recorded. From May 20 through July 7, a grade of “W” is recorded for all courses dropped.
May 19	Last day to drop or withdraw from Summer (12W) Session with a 100 percent refund.
May 26	Last day to drop or withdraw from Summer (12W) Session with a 75 percent refund.
May 27	Memorial Day Holiday.

May 13	Summer Session I (6W1) classes begin.

May 19	Last day to register, add courses, or change sections. Final date to drop courses or totally withdraw with no grade recorded. From May 20 through June 5, a grade of “W” is recorded for all courses dropped.
May 19	Last day to drop or withdraw from Summer I with a 100 percent refund.
May 26	Last day to drop or withdraw from Summer I with a 50 percent refund.
May 27	Memorial Day Holiday.
June 5	Final date to drop courses or totally withdraw from Summer I with an automatic “W.”
June 24	Last day of Summer Session I (6W1) classes. Deadline to withdraw from Summer I with an instructor’s grade of “W” or “F.” Final examination day for Summer I classes.

July 7	Last day to register, add courses, or change sections for Summer Session II (6W2). Final date to drop courses or totally withdraw with no grade recorded. From July 8 through July 28 a grade of “W” is recorded for all courses dropped.
July 7	Last day to drop or withdraw from Summer Session II with a 100 percent refund.
July 14	Last day to drop or withdraw from Summer Session II with a 50 percent refund.
July 28	Deadline to drop courses or withdraw from Summer Session II with an automatic W.”
August 12	Last day of Summer Session II (6W2) classes. Deadline to withdraw from Summer Session II with an instructor’s grade of “W” or “F.” Final examination day for all Summer II (6 week) classes.
