Full Summer Session (12W) – May 18 to August 17

May 18	Summer (12 week) classes begin.
May 18-24	Late registration/schedule adjustment period for Summer (12W) Session. Late fee in effect.
May 24	Last day to register, add courses, or change sections for Summer (12W) Session. Final date to drop courses or totally withdraw with no grade recorded. From May 25 through July 5, a grade of “W” will be recorded for all courses dropped.
May 24	Last day to drop or withdraw from Summer (12W) Session with a 100 percent refund.
May 31	Last day to drop or withdraw from Summer (12W) Session with a 75 percent refund.
May 25	Memorial Day Holiday.
June 7	Last day to drop or withdraw from Summer (12W) Session with a 50 percent refund.
June 14	Last day to drop or withdraw from Summer (12W) Session with a 25 percent refund.
June 30- July 5	Mid-term break (no classes).

Summer Session I (6W1) – May 18 to June 29

May 18	Summer Session I (6W1) classes begin.
May 18-24	Late registration/schedule adjustment period for Summer Session (6W1). Late fee is in effect.
May 24	Last day to register, add courses, or change sections. Final date to drop courses or totally withdraw with no grade recorded. From May 25 through June 2, a grade of “W” will be recorded for all courses dropped.
May 24	Last day to drop or withdraw from Summer I with a 100 percent refund.
May 31	Last day to drop or withdraw from Summer I with a 50 percent refund.
May 25	Memorial Day Holiday.
June 2	Final date to drop courses or totally withdraw from Summer I with an automatic “W.”
June 29	Last day of Summer Session I (6W1) classes. Deadline to withdraw from Summer I with an instructor’s grade of “W” or “F.” Final examination day for Summer I classes.

July 6-12	Late registration/schedule adjustment period for Summer Session II (6W2). Late fee in effect.
July 12	Last day to register, add courses, or change sections for Summer Session II (6W2). Final date to drop courses or totally withdraw with no grade recorded. From July 13 through July 20 a grade of “W” will be recorded for all courses dropped.
July 12	Last day to drop or withdraw from Summer Session II with a 100 percent refund.
July 19	Last day to drop or withdraw from Summer Session II with a 50 percent refund.
July 20	Deadline to drop courses or withdraw from Summer Session II with an automatic W.”
August 17	Last day of Summer Session II (6 week) classes. Deadline to withdraw from Summer Session II with an instructor’s grade of “W” or “F.” Final examination day for all Summer II classes.
